#### Treasurer Report, Hector G

- The checking account currently has \$10,714.06. Savings \$3,000.43 (prudent reserve)
- Hector will send out reimbursement forms and has requested that that receipts (minus mileage)
   be attached after which he will mail out reimbursements
- Contributions received for Feb. & March total \$845.75. Going forward treasurer reports will include contributions identified by group/individuals
- Valerie made a motion to accept the approved treasurers report, seconded and approved

# Intergroup Liaison, Joan S

- Central office moving again to a larger space in the same complex, a flyer is on the website. 3/26/21 is packing day and moving 3/27/21. Volunteers welcome starting at 10a each day. No end time just as long as it takes. Pizza and water will be provided at end of the move
- 2 year lease will be \$900/month, which is \$100 more but for much more space (irony is the new space is a former wine bar)
- Central Office Manager Position open, 2 year sobriety required. Must attend COR meeting, Central office board meeting and oversee Central Office operations. Bonnie will email job description

- Group contributions to CO are down by \$2,000 but individual contributions are making up the difference
- Early Risers Group donated new computers to Central Office for the treasurer and volunteers
- Pamphlet F-3 explains Group contributions to NY, Central Office, Area & District. Standard contributions are 50% to CO, 30% to NY, 10% to Area 93 & 10% to District. Each group is autonomous and can contribute how they choose
- New York is in need of contributions; less need for Area & District because of no travel
- Don't forget H & I contributions, we are not going into hospitals and jail/prisons now, but that will resume

- The question of a Hybrid convention is difficult due to logistics

## **GSR Sharing (PRASSA feedback)**

Jeff-attended orientation, CPC meeting, PI meeting and Carrying the Message meeting. Learned importance of Grapevine – 68,582 subscription to Grapevine and 6,425 to Spanish version, La Vina. Asked that GSR's encourage subscriptions/donations to Grapevine. Considering a new pamphlet aimed at mental health professionals. How to make more accessible to people with disabilities and mental illness. More education needed to AA members on the difference

between prescription psychotropic drugs and drugs of addiction. More patience, tolerance and understanding of people with mental illness needed. Public information – discussions re: public service announcements, TV and newspaper announcements, pamphlets to law enforcement, military bases and placing more Big Books in public libraries

- Upcoming ZOOM workshop regarding critical relationship between AA & Professional community is set for 4/3 9-11a. ID 830 8126 8232 P/W 280122
- Yvonne Format of PRASSA was confusing. She attended some meetings, however, she said a better description of meeting topics would be helpful
- Linda Attended meeting "Are we ready to change the Big Book" and recommends video at https://vimeopro.com/user112910871/big-book-riptab/video/500617913. It's a 20 minute video that invites conversation about topic in groups. She is anti-change, but after talking with younger, newer AA members and video opened her mind for the need to do it. She also attended seniors in Sobriety meeting
- Joe Melody/Harmony Group. Melody is in person and Harmony is online. Some in person
  meetings but most remain online. Young people have hybrid meeting and in-person meetingmasks and social distancing required. Discussed difficulties in translating arcane English into the
  many languages the Big Book has been translated into. German Big Book being re-done because
  of poor translation/poor translatability
- Christine This PRASSA was her 2<sup>nd</sup> experience. She attended the meeting "What AA looks like today and how we can change and adapt and continue to grow". Keep groups inclusive, panels being translated into Spanish and Chinese for PRASSA attendees. There is a Chinese Language meeting in the US
- Butch First time attending PRASSA. Come away with commitment to work with his group regarding meetings are for staying sober, not a place to get a date
- Nick Saturday Morro Bay Speaker meeting is not self supporting using Harbor lights Zoom
- Chenoah Mesa Group stated treasury is way below prudent reserve. They have negotiated a \$300/month rent reduction. Attendance is down. Doing a "group inventory" and encouraged other groups to do the same
- Linda Living in the Steps Group is changing their format
- Peggy Morning Fantastic (Mon/Wed/Fri/Sat/Sun meetings 7am Morro Bay. 3/22 Business Meeting occurred last 10 minutes of meeting to discuss Hybrid/In-person/Zoom meetings
- Deb H First time attending PRASSA. Attended panel regarding changes to Big Book and very complementary regarding Linda's presentation on the subject. Zoom worked well for PRASSA
