- Jeff gave a report on what he learned at the CAPIO (California Association of Public Information Officers) meeting held in November. There were approximately 400 people attending the 50th anniversary meeting of the Association. The purpose of the meeting was to inform those in the public information field on various methods of presenting and promoting their organization to others. The participants were from varied organizations including public safety, school districts, and city and state departments. They looked at plans on how to present their organization. The consensus was that professionals are relying more heavily of disseminating information digitally as a cost cutting method
