- I attended the Assembly Nov. 19 & 20<sup>th</sup> in Fillmore with Christine, who represented the Early Risers Zoomsters Group
- On Saturday we approved the Area Budget. Their expected income for 2023 is \$51,600. Expected expense \$60,885, which = \$9,285 deficit. Please let your groups know, like all of the other service entities, the Area is in need of contributions. Thank you to the groups of District 22 for contributing a total of \$2,465 to the Area last year.  
Reimbursement for mileage was raised to .48 cents per mile
